## Professional Photography Agreement

### Photo Shoot Request Process

Curvue Hideaway + Trees welcomes photography on the farm. However, any interested professional or amateur photographers must first request and be granted permission for their shoot. This ensures that we do not have too many photographers at once or that your shoot does not coincide with any farm maintenance, guest stays, private events, or other conflicts.

1. Send email request for desired photo shoot with dates. Wait for reply with photography application.
2. Complete application and submit via email to [info@ctreesonc.com](mailto:info@ctreesonc.com).
3. Wait for approval to confirm date and times with your photography clients.

### Photographer's Fee:

#### During Christmas Tree Season Operating Hours (Fri 11-5, Sat 11-5 & Sun 11-4): \$75

Christmas Tree Season runs the weekend before Thanksgiving and the weekend before Christmas. NO photography sessions allowed the weekend following Thanksgiving and the first weekend in December. Note: Session must conclude before closing hours. If beyond closing time, an additional \$75 will be charged.

#### During Christmas Tree Season Off Hours (Monday-Friday): \$150

All days are available by appointment. A Curvue Hideaway + Trees employee must be on property.

#### January - October: \$100

All days are available by appointment. A Curvue Hideaway + Trees employee must be on property.

Payment is due at the time of arrival for your scheduled shoot. We accept cash, check, Visa and MasterCard. If at any time you need to cancel your photo session please notify us as soon as possible.

## *Curvue Hideaway + Trees Professional Photography Policies & Rules*

Any and all professional or amateur photographers and their clients must understand and adhere to the following policies and rules, which have been established to allow an enjoyable experience for all our guests.

- Photographers must request permission before setting any client dates or arriving at the farm.
- Please be sure to plan ahead as this is an operating farm and weather conditions vary.
- Please do not call the farm for permission. Only email requests will be considered.
- Permission is given on a single-day basis. Please complete a separate application for additional days.
- We reserve the right to limit the number of photographers on any given day or timeframe.
- Park by the buildings up front. Absolutely no vehicles are allowed in the fields at any time. All props, equipment, furniture, etc will need to be carried to desired location. We recommend bringing a wagon to transport items.
- Be sure to check in with Sean or Brittney upon arrival.
- Please be sure that clients have your contact information. They'll need an easy way to find you. Curvue Hideaway + Trees Staff is not responsible for directing clients to your photoshoot location.
- Any use of professional equipment must be detailed in the photography application.
- Any props used from Curvue Hideaway + Trees property must be pre-approved and must be returned to its original place. If not, you will not be allowed to use this property again in the future. If any fixed or temporary objects are moved or damaged during photography, the photographer will be held responsible for replacement and/or payment.
- Since this is a family establishment, Curvue Hideaway + Trees also reserves the right to prohibit inappropriate attire on premises at any time. Curvue Hideaway + Trees prohibits the use of its property by sexually oriented businesses and/or photographers
- Photo shoots must not block any farm activity such as paths, trails, equipment, buildings, etc.
- Do not leave any personal items unattended. We are not responsible for anything lost, broken, stolen, or left behind. All photo props must be removed at the end of the session. Or a \$100 clean-up fee will be charged.
- Respect and be aware of other farm customers and what is going on around you. This is a working farm so there are often tractors, machinery, and other work happening.
- Respect the work and space of other photographers who may be around the farm. Those not following this policy may be asked to put away their equipment or leave the farm.
- All pets must remain on a leash at all times. Doggie-poo must be removed and disposed of properly. Please bring your own waste bags for doggie clean-up.
- Use care and caution around farm: watch for wild critters, uneven ground, etc. Especially watch your steps as not to step on any newly planted baby trees.
- Tree farm staff reserve the right to ask you to leave the farm at anytime.

THIS INDEMNITY WILL ARISE UPON ANY ACTION OR SUIT OR CLAIM FOR LOSS, DAMAGES AND COSTS WHATSOEVER ARISING OUT OF RELATED TO ARISING OUT OF, OR IN ANY WAY CONNECTED WITH, MY CLIENT'S PARTICIPATION IN ACTIVITIES OR PRESENCE UPON THE PREMISES OF THE FARM. FARM'S DEFENSE AGAINST ANY CLAIM RELEASED, DISCHARGED, AND UPON WHICH PROMISE HAS BEEN MADE NOT TO SUE OR MAKE A CLAIM.
